



**1. How do I enter the contest?**

- I. Purchase any AJINOMOTO products worth RM30 and above at any outlets, Shopee, Lazada or Ajinomoto Food Biz Partner's e-Store.

**2. Is there a minimum purchase amount to enter?**

Yes. You are required to purchase minimum RM30 worth of any AJINOMOTO products to be eligible for the contest.

**3. How many times can I enter the contest?**

There is no limit to the number of submission by each participant. Each participant can submit his/her entry as many times as preferred during the contest period.

**4. Is ONE receipt entitled to ONE entry only?**

No. One receipt can be entitled to one OR more than one entry. The number of entries solely depends on the value of your purchase on AJINOMOTO products.

Every purchase of any AJINOMOTO products worth RM30 is equivalent to one (1) entry, regardless of the number of transaction receipt. For instance,

- Purchase of AJINOMOTO products worth RM30 = One (1) entry,
- Purchase of AJINOMOTO products worth RM60 = Two (2) entries,
- Purchase of AJINOMOTO products worth RM90 = Three (3) entries and so on.

As such, one transaction receipt can be eligible for one (1) OR more than one (1) entry.

**5. When will winner announcement take place?**

**7. Which costs related to the prize will be covered by Organizer?**
