

Terms and Conditions of Ajinomoto Food Biz Partner AJINOMOTO Buy & Win Contest (the “Contest”)

Contest Period:

1. The Contest is valid from **1 September 2024, 00:00:00** to **31 October 2024, 23:59:59** following (UTC+08:00) Kuala Lumpur, Malaysia time zone (“Contest Period”).

Contest Eligibility:

2. The Contest is open to all Malaysian residents, except employees and immediate family members of the “Organizer” and their affiliates, subsidiaries, advertising/PR agencies, elected printing vendors, digital technology providers and other suppliers.

Contest Prize:

3. The Contest offers prizes (“Prize”) as stipulated below.

Contest Submission:

4. Participants can enter the contest by following the steps below:

- 1) Purchase any AJINOMOTO products worth RM30 and above at any outlets, Shopee, Lazada or Ajinomoto Food Biz Partner's e-Store.

- 3) Proof of Purchase: -
 - Proof of Purchase in any receipt form from any outlets, Shopee, Lazada, Ajinomoto Food Biz Partner.
 - Invoice issued by distributor, handwritten receipt **with** company stamp is accepted.
 - Handwritten receipt **without** company stamp will **NOT** be accepted as Proof of Purchase.
- 4) Every purchase of any AJINOMOTO products worth RM30 is equivalent to one (1) entry. For instance, the purchase of AJINOMOTO products worth RM60 equals to two (2) entries, RM90 equals to three (3) entries and so on, regardless of the number of transaction receipt.
- 5) One transaction receipt can be eligible for one (1) OR more than one (1) entry.

Contest Winner Selection:

5. Only Participants who make the purchase within Contest Period and fulfil Contest Submission stated above shall be eligible to win the Prize. Incomplete entries and/or Participants who fail to fulfil the Contest requirement will automatically be disqualified from the Contest without notice.

Winners are given fourteen (14) days from the first contact attempt (maximum 3 attempts to be made) to respond to the WhatsApp private message sent by Ajinomoto Food Biz Partner's WhatsApp Business (+60 12-919 1685). The Organizer will not be held liable in the event that the contest winner(s) cannot be contacted for whatever reasons. The Organizer shall not be held liable in the event of non-receipt or delayed delivery of any notification to the winner(s).

9. Unclaimed prizes shall be withdrawn by the Organizer and the Winner shall no longer be entitled to claim any prize in any form fourteen (14) days after the announcement / private message.

Contest Prize Collection:

10. The Winner will be informed of the location for prize collection via WhatsApp private message (+60 12-919 1685) within seven (7) days from Winner's response to WhatsApp private message of winner announcement.

11. The Winner must schedule a collection appointment with the Organizer prior to the collection.

12. The Winner must collect the Prize in person from the designated location on the agreed date and time. Prize will be forfeited if Winners failed to be present on the agreed collection date.
